

## CERTIFICATE OF COMPLIANCE

### The EC Regulation 1907/2006 concerning Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH Regulation).

Swedish Match Plam Bulgaria AD, your supplier of fire products (*Firestarter Matches, Firelogs, After Barbecue Logs, Giant firestarters, Firediscs, 32Firelighters, Quicklight, Grillbags and Grillboxes*), declares by this statement to have the intention of Full compliance to the REACH Regulation.

Fire Products are "articles" according to Art.3.3 of the REACH Regulation "*Object which during production is given a special shape, surface or design which determines its function to the greater degree than does its chemical composition*".


Within the context of REACH, Swedish Match Plam Bulgaria AD, has different roles:

1. For our production needs we import wax from non EU countries. Therefore, as an "importer", we have done pre-registration:  
*Reference number 05-2114346900-52-0000 for "Paraffin waxes and Hydrocarbon waxes" EC number 232-315-6 and Reference number 05-2114477123-52-0000 for "Paraffin waxes and Hydrocarbon waxes, microcryst." EC number 264-038-1.*
2. For the rest of the chemicals used in the production ("Substances" and "Preparations of substances" within REACH), Swedish Match Plam Bulgaria AD is seen as a "Down Stream User". All suppliers of raw materials, mainly located within the EU, have declared to (pre-) register the chemicals used, if needed, to comply with REACH.

As per REACH Swedish Match Plam Bulgaria has no obligation for registration of substances in articles as our articles (i.e. fire products) do not contain "...substances ... intended to be released from the produced or imported article(s) during normal and reasonable foreseeable conditions of use." Therefore, Swedish Match Plam Bulgaria has no obligation to issue Safety Data Sheets for its products.
